In this context, the purpose of this Privacy Policy is to provide information on the collection, processing and use of the data provided by you in connection with the use of contact page of www.akinon.com website as well as the grade, purpose and scope of transfer thereof to comply with our obligations as Data Controller under Data Protection Law numbered 6698 (“**KVKK**”).

2. The Categories and The Purposes of Collecting and Processing Personal Data

Akinon may process your personal data in the type or categories of name, surname, e-mail, address, phone-number or other personal data you may include contact request; in order to contact and communicate with you and to provide information regarding your request, to provide customer satisfaction. Akinon processed personal data under the conditions and purposed stated under Article 5 of KVKK.

3. Transfer of Your Personal Data

Your personal data may be transferred to our service providers, legal and financial advisors and authorized public authorities in order to perform our purposes under section 2 located in Republic of Turkey.

4. The Legal Grounds of Processing Your Personal Data

Your personal data is in electronic form via our www.akinon.com website. The legal grounds that Akinon relies upon while processing your personal data are the following:

- Your request
- In cases where it is necessary to disclose such information in accordance with applicable laws or regulations or a court judgment or administrative order issued
- Being necessary for Akinon to fulfil its legal obligations as a data controller
- Being necessary for the establishment, exercise, and protection of any right
- Without prejudice to your fundamental rights and freedoms, being compulsory for Akinon’s statutory interests

5. Your Rights Regarding the Protection of Your Personal Data

According to the relevant legislation, you have the right to;

- Learn whether or not your personal data is being processed,
- Request information as to processing if it has been processed,
- Learn the purpose of personal data processing and whether the personal data is used appropriately in line such purposes,
- Know the third parties to which your personal data is transferred domestically or abroad,

- Request correction if your personal data is incompletely or incorrectly processed,
- Request deletion or destruction of your personal data,
- Request the transmission of your correction, deletion, and destruction requests to third parties to whom your personal data has been transferred,
- Object to any consequence occurred against you by analyzing your processed data through automated systems,
- Request compensation in case you incur any damage due to the unlawful processing of personal data,
- Request restriction of data processing activities,
- Request data portability,
- Object to the occurrence of an adverse consequence by analyzing the processed data exclusively through automated systems, and
- Lodge a complaint with the relevant data protection authority and to claim damages in case of impairment because your personal data is processed in violation of the relevant legal legislation.
